See: http://www.nycourts.gov/apps/chrs/</p> <hr/> <p>Go Pass: Eligible grantees may rely on clearances issued by the Go Pass system, operated via a partnership between NYC Service and the NYC Department of Education, without obtaining a program-specific alternate search procedure approval from CNCS. This system documents fingerprint-based New York state-level criminal history information and nationwide FBI checks. Go Pass clearance is available for volunteers (not employees). Non-profits using Go Pass are not required to be based in New York City, but the individual being cleared must serve in one of the five New York City boroughs. To satisfy CNCS regulations on retaining check results, grantees must retain both (1) a photocopy of a candidate's Go Pass identification (keycard) and (2) a dated printout of the Go Pass system query reflecting that an individual's cleared status existed at the time the print-out was produced. A photocopy of a Go Pass keycard by itself without system query documentation establishing current clearance is not sufficient documentation. In addition to using Go Pass, grantees must conduct a nationwide search of the NSOPW before an individual begins to serve and a state-of-residence check if the candidate does not reside in New York. Use of Go Pass does not satisfy these other CNCS requirements.</p>
